Host Bar Service Fees & Options

1. Minimum Staffing Fee for up to 100 guests. (Additional bartender required for more than 100 guests at \$25.00 per hour)

Bartender Fee	\$100.00 (4- hours)
Bar Set-up	\$50.00

2. Host Bar Options:

- (a.) No Limit- Client pays the total bar bill at the conclusion of the event. This option charges based on consumption; by the drink. Client pays total cost of all liquor, beer, wine and soft drinks served plus 15% gratuity. Final charges are calculated at the conclusion of the event. Pre-approval and a deposit is required. Tax and gratuity is added to final balance.
- (b.) Drink "Tickets"- Pre-pay from a chosen number of drink tickets to distribute among your guests. Drink tickets can be redeemed at bar for any beer, wine, liquor or soft drink. 1 ticket=1 drink. Drinks at \$6.00 per drink ticket plus 15% gratuity.
- (c.) Dollar Limit- Pre-pay a select amount inclusive of tax and gratuity. Once amount is reached, bar will be closed.

3. The following methods of payment are accepted: Cash, MasterCard, and Visa.

4. All bar prices include applicable NC Sales Tax.

5. All bartending staff have successfully completed NC ABC Commission Responsible Alcohol Seller/Servers Training Course.

6. All alcohol sales will end 30 minutes prior to end of event. All sales must end by at 11:30p.m.

7. Additional bartenders are available at the rate of \$25.00/hour. (10 day advance notice)

8. Security may be required at the responsibility of the renter as stated in the Goldsboro Event Center rental contract and fee schedule.

9. Pursuant to NC Laws, no person under the age of 21 shall consume alcoholic beverages.

10. All alcohol must be served and consumed in the interior of the building or the patio only.

11. Pursuant to NC Laws, proper identification must be presented. Acceptable forms include:

- *Current Driver's License
- *U.S. Military Identification
- *North Carolina Identification Card
- *Official passport issued by any nation
